Role Description

Co-Educators are required to provide support and assistance to teachers with the delivery and preparation of the requirements of the College's curriculum, supporting students to achieve their personal best. This support will include working closely with individual and small groups of children on pre-prepared and structured programs under inclusive learning and classroom teacher direction.

Co-Educators are expected to nurture positive relationships with children, parents and colleagues. The role requires a high level of collaboration with colleagues to ensure the best possible outcomes for children.

Essential Requirements

- Certificate III in School Based Educational Support or equivalent
- relevant experience appropriate to the role
- experience in using contemporary digital technologies
- current Working With Children Check and RRHAN-EC
- First Aid accreditation, CPR, Asthma and Anaphylaxis accreditation





Selection Criteria

Learning Diversity

- support students with Autism Spectrum Disorder (ASD) and Attention Deficit Disorder (ADD), using tailored strategies to meet their unique needs
- apply knowledge of the Zones of Regulation to help students develop emotional regulation and self-management skills
- provide intensive, individualised support for students requiring Tier 3 interventions, addressing complex learning and behavioural needs support students with differentiated learning needs
- identify any barriers within the learning environment and implement appropriate adjustments
- adapt learning engagements according to Student Support Plans
- provide direct and timely support to students who have additional learning or support needs
- provide meaningful and regular feedback to students on their progress
- provide direct learning support to students who require an adjusted learning program
- assist teachers with the implementation of strategies for learning and positive behaviour management
- assist teachers to prepare learning resources to meet individual student learning needs

- skilled in implementing structured support for neurodiverse students, including those with ASD and ADD
- strong communication and interpersonal skills
