## Application and Enrolment

A \$75 non-refundable application fee (\$100 for multiple siblings) is payable on application to the College.
A non-refundable enrolment deposit of:

* \$500 Enrolment Deposit for ELC to Year 6
* $\$ 1,200$ Enrolment Deposit for Year 7 to Year 12

This enrolment deposit is applied to the first term tuition fees, Reception to Year 12.

## Family Concessions

A sibling concession on tuition fees applies for students attending Concordia Campus and/or St John's Campus (excluding ELC) at the same time.
2nd child in family $10 \%$ off tuition fee
3rd child in family $20 \%$ off tuition fee

## Composite Fee

This fee covers most curriculum requirements including use of textbooks, school magazine, project materials, co-curricular activities, cost of year level camps and most excursions.

## IT Levy

This fee includes the provision of a fully-serviced device, software and campus web access for the school year.

## Building Fund Contribution ${ }^{1}$

The Building Fund Contribution is a compulsory fee of $\$ 300$ per student, up to a maximum of $\$ 600$ per family. This contribution assists in the maintenance of College buildings and facilities.

## Payment of Fees

Fees may be paid by the following methods:

1. Annually in advance, by 30 November of the preceding year, with a $4 \%$ discount on tuition fees.
2. Four instalments, by 30 November of the preceding year, 28 February, 31 May and 31 August.
3. By arranged monthly direct debit/credit card instalments.

Payment is due by the end of the month in which accounts are rendered. Payment options can be found on the base of your Statement. It is not College Policy to carry fees forward into the next billing year. Hence, fees under agreed payment plans with the College must be finalised by the end of October each year.
The Concordia College Board reserves the right to terminate the schooling of a student whose fees are in arrears. The College also reserves the right to charge a late payment fee and the cost of recovery fees on overdue accounts.

Family accounts will not be split and will be billed as per the enrolment form. Where this represents a separated family, the College expects the enrolling parents/caregivers to arrange payment plans between themselves ensuring all fees are up to date.

All school account payments must be up to date or an approved payment plan in place and maintained before a student is permitted to attend any non-curriculum trips or excursions for which a charge is levied.

When a student is to be withdrawn from the school, parents are required to give the Principal one school term's notice, in writing, before the withdrawal date, otherwise parents will be liable for an additional term's fees, in lieu of notice.

## Concordia Parents and Friends Membership

Included on the first term account is an annual charge of \$40 per family for membership of the Concordia Parents and Friends. This contribution enables the group to support community engagement and projects.

## Early Learning Centre (ELC)

## Cost per Student per day

ELC term program 7.30am - 6.00pm

Optional care during term breaks 7.30am-6.00pm \$140 per day

+ The ELC is an approved Long Day Care Provider. Eligible families may access the Child Care Subsidy for ELC fees.
+ The ELC is open for 48 weeks a year, however attendance during term breaks is optional.
+ Bookings and accounts are managed through the online management system Fully Booked.
+ Fees are paid fortnightly by direct debit through Ezidebit.


## Term Breaks

+ Bookings can be made up until 6 pm on the day before care is required.
+ Cancellations can be made until 6pm on the day before care is required. Bookings cancelled after 6pm the day before care is required will incur the full fee.
+ Late fee of $\$ 1$ per minute for the first 10 minutes and $\$ 5$ per minute thereafter will apply after 6pm.


## Old Concordians Association Membership Fee

A once off fee of $\$ 250$ per student for membership to the Old Concordians Association (OCA) will be invoiced on the first fee account (Reception to Year 12). This membership fee provides a lifetime membership to OCA upon leaving the College at any year level.

## School Bus (if applicable)

## Out Of School Hours Care (OSHC)

## Cost per Student per session

Before School Care 7.30-8.30am \$15 permanent and \$17 casual booking
After School Care to 6.00pm

Vacation Care 7.30am - 6.00pm \$30 permanent and \$32 casual booking Eligible families will receive Child care Subsidy.

Concordia OSHC use a Child Care Management System called Fully Booked to manage our bookings/accounts. This is a completely online system which gives parents the ability to easily manage all Before and After School, and Vacation Care bookings. Fully Booked in turn uses a simple debit system called Ezidebit to take payments.

+ A permanent booking is considered as any booking made 7 days, or more, prior to the required day of booking (ie. An ASC booking required for Tuesday would need to be made by close of business on the preceding Monday).
+ A casual booking, therefore, is considered as any booking made less than 7 days prior to day of the required booking.
+ Cancellations for Before or After School Care bookings should be made by close of business the previous day, to avoid being charged full session fees.
+ Cancellations for Vacation Care bookings should be made by close of business three days prior, to avoid being charged full session fees.
+ Late fee of \$1 per minute for the first 10 minutes and \$5 per minute thereafter will apply after 6pm.
+ Enrolment Fee of $\$ 30$ per child upon their enrolment into OSHC. This fee will cover the child for their entire primary school life.
